GENERAL POSITION DESCRIPTION

To supervise and maintain the safe movement to and from Towanits Indian Education Center when crossing roadways.

DUTIES AND RESPONSIBILITIES:

1. Assist children on their way to and from Towanits in safely crossing roadways.
2. Watch for gaps in traffic and walk children across the roadway while holding a “Stop” sign in such a manner as to be visible to approaching vehicles.
3. All other duties as assigned by supervisor.

QUALIFICATIONS:

1. Must have the ability to follow oral and written instructions
2. Must have the ability to deal effectively and courteously with students and the general public
3. Must be in good physical condition that will permit adequate job performance
4. Minimum High School Diploma or equivalent.
5. Must be CPR and First Aid certified
6. Possess a valid California Driver License and be insurable through the tribe, preferred.
7. Must be willing to participate in training for continued upgrading of job skills.
8. Must successfully complete a pre-employment drug/alcohol screen and background investigation.
9. If previously employed within the Tule River Indian Tribe of California entities, you must have acceptable work history.

WORKING CONDITIONS:

Position requires prolonged sitting, standing, walking, reaching, twisting, turning, kneeling, bending, squatting, and stooping in the performance of daily activities. The position also requires grasping, repetitive hand movement and fine coordination in preparing reports using a computer keyboard. Additionally the position requires near and far vision in proofreading correspondence and work related documents. Acute hearing is required. Frequently must be able to lift up to 10 pounds, normally must

be able to lift up to 30 pounds, and occasionally must be able to lift up to or over 50 pounds. This job also may require the use of a vehicle, and an employee must be able to have those repetitive motions and coordination associated with operating a motor vehicle.
